PROCLAMATION LETTERS PATENT

Whereas, the League of Indian Nations of North America Acknowledge,

We as clean and pure nation descended from the inhabitants of Africa, do not desire to amalgamate or marry into the families of the pale skin nations of Europe. Neither serve the gods of their religion, because our forefathers are the true and divine founders of the first religious creed, for the redemption and salvation of mankind on earth. Therefore we are returning the Church and Christianity back to the European Nations, as it was prepared by their forefathers for their earthly salvation. While, We the Moors of North, South, and Central Americans are returning to our Ancestral forefathers Tribal Ways, which was founded by our ancient forefathers for our earthly and divine salvation.

The Industrious acts of the Moslems of Northwest and Southwest Africa. Whereas, the League of Indian Nations of North America Acknowledge,
The Royal Proclamation 1763, October 7, 1768

Whereas We have taken into Our Royal Consideration the extensive and valuable Acquisitions in America, secured to our Crown by the late *Definitive Treaty of Peace*, concluded at Paris, the 10th Day of February last; and being desirous that all Our loving Subjects, as well of our Kingdom as of our Colonies in America, may avail themselves with all convenient Speed, of the great Benefits and Advantages which must accrue therefrom to their Commerce, Manufactures, and Navigation, We have thought fit, with the Advice of our Privy Council, to issue this our Royal Proclamation, hereby to publish and declare to all our loving Subjects, that we have, with the Advice of our Said Privy Council, granted our Letters Patent, under our Great Seal of Great Britain, to erect, within the Countries and Islands ceded and confirmed to Us by the said Treaty, Four distinct and separate Governments, styled and called by the names of Quebec, East Florida, West Florida and Grenada, and limited and bounded as follows, viz.

Proclamation Treaty of Peace and Friendship.

Between the United States of America and the Emperor of Morocco was conducted and signed at Meccanez of the sixteenth day of September, Anno Domini eighteen hundred and thirty six, etc.

US Constitution Article VI

- {1} All Debts contracted and Engagements entered into, before the Adoption of this Constitution shall be as valid against the United States under this Constitution, as under the Confederation.
- {2} This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, and Thing in the Constitution or Laws of any State to the Contrary notwithstanding.
- {3} The Senators and Representatives before mentioned, and the Members of the several state Legislatures, and all executive and judicial Officers, both of United States and of the several State, shall be bound by Oath or Affirmation, to support this Constitution; but no religious Test shall ever be required as a Qualification to any Office or public Trust under the United States.

Articles of Confederation March 1, 1781, Article X:

Canada acceding to this confederation and adjoining in the measures of the United States, shall be admitted into and entitled to all the advantages of this Union, but no other colony shall be admitted into the same, unless such admission be agreed to by nine States.

Article XII

All bills of credit emitted, monies borrowed and debts contracted by, or under the authority of Congress, before the assembling of the United States in pursuance of the present confederation, shall be deemed and considered as a charge against the United States for payment and satisfaction where of the said United States, and the public faith are hereby solemnly pledged.

Let it be known the League of Indian Nations of North America on this 18th day of October 2018 this Letters Patent Certificate of Recognition to the MOORS Tribal Name(s) EL and BEY and acknowledge that their claim to their birthright and accept the value of oral history and the surnames entered on the various Indian Census Rolls, and supports their efforts to revive and restore the culture, traditions, practices and spirituality of their ancestors who populated the North, South and Central West America and the island.
